The **Newsletter** of the **Department of History and Philosophy of Science (PHS)** aims to inform about activities of its members of staff and students. The History and Philosophy of Science is an interdisciplinary academic field, which studies science as a complex historical, social, and cultural phenomenon and highlights the philosophical dimensions of its theories and practice. It examines the philosophical, conceptual, and historical approaches to science in general, as well as to a variety of particular research fields, including the humanities and social sciences, natural sciences, psychology and cognitive sciences, life and medical sciences, mathematics and logic, and new technologies. The [faculty members](#) of the Department include some of the world experts in their respective fields, while several of the members lead or collaborate in [international research projects](#). The Department consists of three Divisions: History of Science and Technology, Philosophy and Theory of Science, and Technology, and Cognitive Science. It offers the sole [undergraduate programme](#) of studies on History and Philosophy of Science in Greece and 9 [postgraduate programmes](#) of studies in both Greek and English, which cover a wide range of philosophical topics, the history of science and technology, studies in society, science and technology, digital humanities and augmented textual studies, and cognitive psychology. PHS is among the highest rated of humanities departments in Greece, in terms of international research citations.

Awards and Distinctions

- Assoc. Professor **Stathis Arapostathis** (PHS) has been appointed in the **multidisciplinary Scientific Advisory Board for the Reconstruction of the Prefecture of Thessaly**. The Advisory Board has been instituted by the newly

elected Governor of Thessaly to provide policy advice, and to plan the sociotechnical transition of Thessaly in the aftermath of the latest floods and within the context of the Climate Crisis.

Research Projects

- [Governing Just Sociotechnical Transitions: A Co-productionist Model of Sustainable Futures in the Agrifood sector](#) (Go-JuST). The overarching aim of Governing Just Sociotechnical Transitions (Go-JuST) is to identify and analyse the critical factors and dimensions conditioning the potential to achieve just agrifood transitions. It studies the history of regional transitions to draw policy insights that will aid stakeholders in Greece's regional transition initiatives to maximise justice and anticipate and reduce injustices. Under the leadership of Assoc. Professor **Stathis Arapostathis** (PHS), a group of six researchers will work on the topic. Our novel methodology engages stakeholders in the co-creation of just transition pathways, offering a co-productionist model of governance for transitions in the Greek agrifood sector. Go-JuST is oriented to the following objectives: (1) Review and enrich the theoretical approaches of just transitions. Create the setting for interdisciplinary research and societal engagement; (2) Introduce a model that identifies types of injustices (visible or hidden) and analyses the context of their emergence and configuration; (3) Provide policy insights grounded in critical and evaluative approaches of analysis that establish "transition platforms" to

support deliberation and reflexivity in the making of transition; (4) Empower stakeholders to prioritize justice as they enact and assess transformational innovations and sociotechnical change. Go-JuST centers our analysis in Thessaly, which is a key center of the Greek agrifood sector. Go-JuST offers a replicable model for other regions and a model that can function as a governance tool at national scale.

- [PANGEA4CALVAL Horizon Europe 2022-2025](#). It is part of a major project the is run and coordinated by the Hellenic Observatory of Athens aiming in establishing a Geophysical Observatory for the Mediterranean basin in the island of Antikythira. This is a project of atmospheric physics and modeling. Under the leadership of Assoc. Professor **Stathis Arapostathis**, a postdoc researcher **Chrysa Karpantziani** will work in Work Package 6 and will conduct analysis of the data management and ownership, the management of knowledge, and the protocols of ethical conduct of research. The analysis will follow the Responsible and Open Research and Innovation approach and aims to result in standard setting and the establishment of best practices.

- The PhD Candidate **Panagiotis Kalyvas** of the HPS Department gained

a **three-year scholarship** (2023-2026) from the **Hellenic Foundation for Research & Innovation** (4th Call for H.F.R.I. Scholarships to PhD Candidates) working on the research

project “Contemporary Perspectivism as a Conceptual-Methodological Framework of Scientific Inquiry in Modern Physics and Beyond”. Scientific advisor of the project is Professor **Vassilios Karakostas** (PHS).

- Professor **Katerina Ierodiakonou** gave an invited talk on “**Mixed Colours in the *De Coloribus*” (24 November 2023)**, in the framework of the international conference “From Plato to Plotinus. A Conference in Honour of Eyjólfur Kjalar Emilsson” in Oslo, Norway.

- The [1st STS NKUA Conference, entitled *STS in Greece: What we have so far, how to move forward*](#), was organized by the anglophone Interdepartmental Graduate Program ‘Science, Technology, Society—Science and Technology Studies’, which is offered jointly by the Department of History and Philosophy of Science & the Department of Informatics and Telecommunications, School of Science, NKUA. The conference included 30 presentations, which were all well attended. It took place at the amphitheaters of the Department of History and Philosophy of Science on the **25th and 26th of November 2023**. According to the data presented by its director, Professor **Aristotle Tympas**, the theses completed in the context of this program are 32, plus 12 theses who were written by visiting Erasmus students, from the ESST European network (the data was collected with the valuable assistance of Eleftheria Savva, the program secretary). These 44 theses cover a range of fields and topics from an STS perspective: Artificial Intelligence, Big Data, Telecommunication: 26 (Artificial Intelligence: 8, Algorithms: 2, Big Data: 6, Automation, Robotics and other relevant topics: 12), Science, Technology, Economics: 3, Science and Technology Policy & Law, Science, Technology: 9, Biosciences, Biotechnology, Medicine: 11, Environment and Sustainability: 8, Gender, Science, Technology: 5, Science, Technology, Ethics & Philosophy of Science and Technology & Science, Technology, Literature: 13.

Over 90 students have so far graduate from this program. In the last three years, 44 candidates from 4 continents have applied to it, representing a broad range of countries (USA, China, Brazil, Germany, UK, Belgium, Norway, Japan, Russia, Georgia, Israel, Turkey, Lebanon, Syria, Ghana, Cameroon, Nigeria, The Philippines, Pakistan, Bangladesh). 14 of them were admitted to the program, including graduates of some of the highest-ranking US universities (e.g. Harvard, MIT, UCLA). The 12 ESST

students who came to the program through Erasmus agreements to write their theses also came from a range of countries (Germany, UK, The Netherlands, Austria, Italy, Spain, Norway, Bulgaria, India). Noticeably, the students of the program come from all areas of science (from biology to informatics) and engineering (especially electrical and electronics engineering), as well as from most of the disciplines of the human and social sciences.



Drakopoulos, Stavros, [Εισαγωγή στις Αρχές της Σύγχρονης Οικονομικής \(Introduction to the Principles of Contemporary Economics\)](#), 2nd Augmented Edition. Athens: Papazisis, 2023.

Abstract: The primary aim of this textbook is to present basic topics of Economic Science in as simple but accurate and scientific a way as possible. It is written at an introductory level and is the product of many years of experience of teaching undergraduate students who had not been taught economics at the university level. The first seven chapters (chapters 1 to 7) deal with fundamental issues in Microeconomics and the next six chapters deal with fundamental issues in Macroeconomics (chapters 8 to 13). In each chapter, the learning objectives and the key concepts are outlined. The level of analysis does




not assume knowledge of economics but introduces economic thinking using concrete examples and diagrams that facilitate the understanding of economic phenomena. Mathematical analysis is limited to where it is strictly necessary. In several cases, there are numerical examples and exercises which show how the theoretical concepts can be applied.



Abstract: In this volume a distinguished international team of scholars examines the history of drugs within all the major medical traditions of the medieval Mediterranean, namely Byzantine, Islamicate, Jewish, and Latin, and in so doing analyses a considerable number of previously unedited or barely explored texts. A Mediterranean-wide perspective permits a deeper understanding of broader phenomena such as the transfer of scientific knowledge and cultural exchange, by looking beyond single linguistic traditions or political boundaries. It also highlights the diversity and vitality of the medieval Mediterranean pharmacological tradition, which, through its close links with cookery, alchemy, magic, religion, and philosophy, had to be able to adapt to multiple contexts, not least to changing social and political realities, as in the case of drugs as diplomatic gifts.

Abstract: Most of the current and past




academic controversies in economics are, explicitly or implicitly, centred around the application and form of economic policy. This is particularly evident in the post-WWII period, with the appearance of economic policy as a distinguishable subfield, but important elements of various economic policy issues can be found throughout the history of economic thought. This book discusses various topics in economic policy – such as questions over state spending and taxation, income redistribution, and the role of money – with each chapter focusing on a particular period or major school of economic thought ranging from the ‘prehistory’ of economics up to the present day. Specific chapters of the volume cover the main schools of economic thought from different national and theoretical traditions, incorporating mercantilism, the Physiocratic School, the German Historical School, Marxism, the Austrian School, institutional economics, Keynesian economics, behavioural economics and more.

- The [MSc in Augmented Textual Studies: Text Encoding and Text Mining](#) focuses on the Digital Humanities field area of encoding texts and mining knowledge from them. Given that the written texts covers all aspects of human life and is the main means of production, circulation and use of information, which in recent years has been accumulated and deposited on the World Wide Web, the importance of this master's program is obvious. The international reality highlights the need to encode texts and manage them exploiting the Internet and Semantic Web technologies to meet research purposes - mainly in the Humanities. In this environment of rapid transformation of texts into electronic versions with added value information, the MSc course will produce highly specialized scientists, able to participate

in research activity and deliver rich morphological, syntactic, and semantic encoding to Greek and Latin texts. Hence, the aim of the MSc in Augmented Textual Studies: Text Encoding and Text Mining is to offer scientific expertise and to be a starting point for the development and expansion of research in Textual Studies, which is an evolving and of significant scientific, social and economic importance domain. In particular the MSc aims to contribute to the post graduate studies and the research in following areas:

- Digitization and management of textual content.
- Technologies and methods for linguistic data.
- The environment and the processes for the production of digital documents and their circulation in the Internet.

- The encoding of the texts across the range of levels of their linguistic analysis.
- Text mining and the semantic annotation of texts.
- The life cycle of the curation of the information contained in the texts, ensuring integrity, preservation and long-term access.

The MSc in Augmented Textual Studies: Text Encoding and Text Mining is organized by the of the **Department of**

Digital Industry Technologies and the **Department of History and Philosophy of Science** of the Faculty of Science of the National and Kapodistrian University of Athens.

The duration of study is four (4) academic semesters. The Curriculum includes three (3) semesters dedicated to courses. The 4th semester is devoted entirely to the preparation of a master's thesis.
